



## **Pigeon River Canines Sales Contract & Health Guarantee**

### **Our Health Guarantee**

- 1. Your puppy has been checked by our vet before leaving our place and we will provide you with a report of this physical exam.**
- 2. A buyer may have their new puppy checked by a licensed veterinarian with five days of purchase. If the puppy is found not to be in good health, other than the nonreturnable reasons listed below, it may be returned for a full refund with these five days. Any return of the pup will be at the buyer's expense. NON-RETURNABLE REASONS ARE AS FOLLOWS: Cosmetic Flaws, Abuse or Neglect, Fleas/Ticks, Parasites, Coccidia, Giardia, Kennel Cough, Hernias, or Luxating Patellas Grade 1 or 2.**
- 3. The dog will not be replaced if it should die from conditions resulting from abuse, neglect accident or sickness contracted after purchase. Hypoglycemia is NOT considered a genetic defect. Heart murmurs graded 1 or 2 are not considered life threatening.**

### **Deposit Policy**

- 1. A puppy cannot be placed on hold without a deposit. The buyer understands that by placing a deposit on a specific puppy, it is considered a commitment to buy, therefore, the deposit is NONREFUNDABLE. In the event that something unforeseen should happen to the puppy that the deposit is placed on the seller will refund your deposit.**

### **Buyers Responsibilities**

- 1. You, as the new owner, are REQUIRED to A.) Keep dog current on all vaccinations, B.) Keep dog on monthly heart work preventative and C.) If illness occurs, the dog is to receive immediate veterinarian care and all**

prescribed treatment is to be followed. Proper puppy care is required to validate this health guarantee. If seller feels proper puppy care was not performed, seller can void this contract.

### Additional Sales Terms

The seller does NOT guarantee size, color, conformation, show/breeding quality, breeding ability, or behavioral characteristics of this puppy. This includes puppies that are purchased with full registration and /or with the intention of breeding. This guaranteed extends to the original purchaser only. If the pup is resold, given away or transfers ownership, the guarantee is void. THE SELLER IS NOT RESPONSIBLE FOR ANY VETERINARIAN COSTS INCURRED BY THE PUPPY AFTER IT LEAVES OUR PLACE.
